- 1. The meeting was called to order by Chairman Nuttleman at 7:30 pm. Roll call: Chairman (Chr.) Nuttleman, Supervisor (Sup.) Caulum, Supervisor (Sup.) Hoth, Treasurer (Tr.) Anderson, and Clerk (Clk.) Hart-Pollock present. Chairman (Chr.) Nuttleman noted the meeting was properly posted.
- 2. Tr. Anderson read the Treasurer's report for November 2020 available account balances total \$300,055.01 and Rockland Cemetery account balance is \$20,396.14. Chr. Nuttleman noted for the record that the September 2020 Treasurer's Report was received.

- 6. Bangor School District Superintendent Dave Laehn shared with the board the following updates with the school district:
 - The school district is in good shape, has great staff, and great facilities.
 - Enrollment is increasing with approximately 610 students. With the new subdivision being developed this will be a positive for enrollment.
 - The loan for the middle and high school are paid off along with the demolition of the old high school. The elementary school renovation has 7 years to be paid off but hope to pay off sooner.
 - Mr. Laehn will be retiring at the end of the school year, June 30, 2021. The interview process will begin in February 2021 and hire a new superintendent in March to take over July 1.
- 7. No report for Town Zoning Administrator Bill Larson as he was absent.
- 8. There was discussion on the use of ATV and UTV's on township roads. It was discussed an ordinance needs to be developed. Chr. Nuttleman motioned to table to the January 2021 meeting, second by Sup. Hoth. Voice vote, all ayes, motion carried.

 - Judy Sommers informed the board that she is resigning from the Planning Commission Committee.
 - Tr. Anderson will not be collecting taxes in person. Tax payments can be mailed to her or dropped off at the town hall drop box.
